# 2025 ACP Leadership Day April 28-29, Washington, DC Action Needed!

Leadership Day is early this year! This day enables the College to increase its presence on Capitol Hill and bring our issues of concern to U.S. lawmakers. ACP members will receive two days of in-depth briefings on the College's legislative priorities and an opportunity to meet with elected officials. Attendance is limited to ACP members only.

If you are an active Chapter member interested in attending ACP Leadership Day this year, **please complete** <u>this self-nomination form</u> in **its entirety by February 5, 2025.** 

The Health & Public Policy Committee leadership will review the nominations and select a diverse group of members to represent the Chapter in Washington, DC. Congressional districts (Districts 1-10), Chapter activity and practice type will be taken into account during the selection process.

If selected, you will be responsible for registering yourself for Leadership Day with ACP. The Chapter will send the link to this portal in your selection notification or as soon as it is available. You will also be responsible for making your hotel arrangements. The Chapter will provide the information and link for the ACP host hotel, The Westin, but you are not required to stay in the host hotel. Reimbursement of hotel rooms will be **made up to the group rate** (\$389/night) secured by ACP at The Westin. If your hotel room rate is above the group rate of \$389/night, you will be responsible for the difference. You will be responsible for submitting your receipts to the Chapter for reimbursement of your hotel room rate, taxes and parking following the event. If you are local to the DC area, the Chapter will reimburse your parking fees with receipts. Reimbursement of registration fee, hotel expenses or parking fees will be made are contingent upon attendance, will be made after the event and dispersed as one check per person.

# Resolutions

# Spring 2025

Commenting is now open for the <u>Spring 2025 slate</u>. Please take some time to review these resolutions and share your comments. The Board of Governors will discuss the Spring slate of Resolutions during the April meeting in New Orleans.

## Fall 2025 Resolutions

The ACP has a call for Resolutions twice each year for the Fall and Spring Board of Governors Meetings. The Board of Governors (BOG) Resolutions Process was instituted in 1985 as a means for the ACP membership to have formal input to the Board of Regents (BOR), the policymaking body of the College. A resolution reflects the grassroots voice of ACP. A resolution is a proposal that asks the ACP to take a position and/or an action. Any ACP member can submit a resolution to his or her ACP Governor for consideration by the local chapter council. A resolution consists of at least one directive ("Resolved clause") accompanied by supporting statements ("Whereas clauses"). If you have a proposal, please review the Resolutions Guide and submit it to the Governor. The deadlines to submit a Resolution for consideration are typically in May for the Fall BOG meeting and December for the Spring BOG meeting.

There is a current Call for Fall Resolutions! The deadline for submitting new resolutions to be heard at the Fall 2025 Board ofGovernors Meeting is March 28, 2025.

## Help Promote Action Alert Urging Congress to Prioritize Health Care Issues

As a new Congress convenes, ACP is asking ACP members to urge their members of Congress to prioritize health care and pass legislation that addresses Medicare physician payment cuts, extends telehealth flexibilities long-term, and reforms the prior authorization process.

#### Background

The last Congress failed to pass legislation that would have addressed these issues in an end-of-year package. As a result, a 2.8 percent cut to physician Medicare payments went into effect on January 1, 2025, and a number of bipartisan health care policies were not finalized, including prior authorization reform and a long-term extension of telehealth coverage flexibilities. We need your help to get these critical issues resolved.

The 2.8 percent cut to Medicare physician payment that went into effect on January 1, is the result of complex budgetary rules and systemic flaws within the physician fee schedule (PFS). This is the fifth straight year that the final PFS rule includes an across-the-board cut to payment rates for physicians and other clinicians. Congress has passed legislation over the past four years to mitigate portions of these cuts, and needs to act again to stop the current cut.

Last year, ACP <u>supported</u> the Improving Seniors' Timely Access to Care Act, which would protect patients from unnecessary delays in care and reduce administrative burden on physicians by streamlining the prior authorization approval processes in Medicare Advantage. The legislation had bipartisan support with <u>231 cosponsors</u> in the House and <u>59 cosponsors</u> in the Senate. ACP supports a re-introduction of the Improving Senior's Timely Access to Care Act in the current Congress and its inclusion in any new package of health care legislation.

ACP has also supported a long-term extension of telehealth flexibilities that included the removal of geographic restrictions, expansion of originating sites required for telehealth visits, audio-only telehealth access and that allows for Federally Qualified Health Centers (FQHCs) and Rural Health Clinics (RHCs) to continue providing telehealth service. In the government-funding continuing resolution (CR) passed by Congress last month, these telehealth flexibilities were extended but only until March 2025 when the resolution expires. Congress will need to act again to extend these flexibilities.

## Statement from Leading Physician Groups on Announcement to Withdraw U.S. from the World Health Organization

The statement below is issued by the American Academy of Pediatrics, American Academy of Family Physicians, American College of Obstetricians and Gynecologists, American College of Physicians, American Osteopathic Association and American Psychiatric Association:

"The recent announcement to withdraw the United States from the World Health Organization (WHO) will limit our ability to collaborate and coordinate on public health issues that impact individuals and their families here and around the globe. As leading medical organizations representing more than 600,000 physicians in the United States, we share the goal of safe, healthy, and disease-free patients and communities. Remaining part of the WHO is one way we can ensure our nation's success in achieving this goal for all the patients we care for. "For more than 70 years, the WHO has played a leading a role in protecting, supporting, and promoting public health in the United States and around the world. Withdrawing from the WHO will hamper our country's ability to predict and respond to major public health emergencies and limit access, communication and information sharing to a global network of health professionals.

"We urge Congress to reject the administration's proposal to withdraw from the WHO and ensure the United States can continue to have a seat at the table where critical public health decisions are being made."
