### Led the Charge to Reduce Administrative Burdens



### **Shaped Prior Authorization Reform:**

- Unwavering advocacy resulted in the CMS Interoperabilty and Prior Authorization final rule requiring Medicare Advantage plans to make decisions within 72 hours for expedited requests
- Joined ACP chapters in NJ, OH, KY, and NH to support to support efforts in their state to pass legislation that would reduce the burden of prior authorizations
- Empowered members with a toolkit containing background knowledge and reform resources and generated nearly 2,000 grassroots advocacy messages from ACP members supporting prior authorization reforms

## Worked to Improve the Daily Practice Environment

- Protected Physician Payment:
  - ACP successfully drove the inclusion of report language in Congress' appropriations bills for 2025, calling for a review of whether CMS has overestimated utilization of certain Medicare codes to prevent unnecessary cuts Recommended CMS support key reforms and oppose
  - cuts to physician payment rates, with continued efforts to secure adjustments for January 2025 Mobilized over 5,000 grassroots advocacy actions to
  - support physician payment protections Advocated for Strengthened Medicare Access: Urged
- Congress to pass the "Strengthening Medicare for Patients and Providers Act", to ensure annual inflation updates and protect patient access to care Protected Telehealth Services: Advocated for extended
- telehealth flexibilities, securing continued coverage for audio-only visits and delaying in-person requirements for behavioral health services **Defended Scope of Practice:** Actively opposed legislation
- that would expand pharmacist scope of practice beyond safe limits; developed a toolkit of resources for members to help them advocate at the state level
